Workshop description

In the Technical Configuration Level 1 training workshop, participants will learn how to install and configure the XProtect® Corporate VMS to specifications for realistic scenarios.

During the workshop, participants act as Integration Technicians to install the different XProtect Corporate VMS components to accommodate a customer's business needs. This includes detailed steps on how to configure various hardware, product specifications, and real-world requirements. At the end of the workshop, participants will set up a new XProtect Corporate VMS using a detailed specification.

Attending this workshop helps prepare participants to take the Milestone Certified Integration Technician (MCIT) online assessment.

The course duration is three full working days, 9 am to 5 pm, with a total seat time of 18 hours. Coffee and other refreshments are provided throughout the day and lunch is provided.

Workshop format

This three-day training workshop consists of a series of hands-on exercises that help participants configure features of the Milestone XProtect Corporate VMS to address realistic scenarios.

Step-by-step instructions guide participants as they work to install, configure, and demonstrate core features of the Milestone XProtect Corporate VMS. Discussion topics address common solutions.

Participants leave with a detailed sequential checklist and annotated notes to help transfer their knowledge to the field.

Target audience

Field technicians who are responsible for installing and configuring video surveillance systems are encouraged to attend this workshop.

Case Study: Acme Retail (Facilitator-led exercises)

Configure the Network and Server

- Document the network settings for your server
- Connect your local computer to network and verify the connection
- Download the class material from the trainer's server
- Open a Remote Desktop Connection to your server
- Adjust the time zone of your server to match the time zone of your laptop
- Verify Microsoft SQL server access and permissions

Install Milestone XProtect Advanced Components

- Install the Management Server to your Server
- Verify that the Management Server is running

- Download and install the Milestone Mobile Server
- Verify that the Mobile Server is running
- Install the Recording Server to your Server
- Verify that the Recording Server has started
- Download and install the Management Client to your laptop

Configure the Acme Retail HQ Recording and Storage Settings

- Open the Management Client and log in to the Server

- Add archive settings for the Acme Retail HQ Recording Server
- Define retention and grooming for the Acme Retail HQ Recording Server

Add Devices to the Acme Retail HQ Recording Server

- Add devices, create device groups, and assign devices to default groups
- Add a Direct Show device with manual scanning
- Add a video file to a Direct Show device
- Install the XProtect Screen Recorder on your laptop
- Add the Screen Recorder as device
- Create additional device groups
- Add devices to camera groups

Configure Cameras

- Configure camera settings and define video streams
- Configure Recording settings
- Configure a Privacy mask
- Configure 360° Lenses
- Create Motion Detection
- Configure the Microphone to retain recorded audio for only 24 hours

Introducing Rules

- Create the rule: RECORD – Always on outdoor cameras
- Create the rule: FRAMERATE – Keyframe normal, full FPS on motion on outdoor cameras
- Verify that the rules are working
- Create new rule: RECORD AUDIO – from admin reception front door on doorbell activated

- Add a Time Profile
- Add a Day length Time Profile
- Edit Rule: FRAMERATE – Keyframe normal, full FPS on motion on outdoor cameras outside work hours

Configure a Smart Wall

- Create and Name a Smart Wall
- Add Monitors to the Admin Office Security Room Smart Wall
- Specify the Smart Wall monitor layout
- Create Smart Wall Presets
- Create new rule: SMART WALL – Show Cameras with Motion on left monitor
- Create new rule: SMART WALL – Trigger Lockdown preset on Lockdown User Defined Event
- Create new rule: SMART WALL – Text notification on robbery in Store #1
